SUBJECT: CORONAVIRUS RELIEF FUNDING REQUESTS

We have reviewed your request for federal funds to help pay for your agency's costs in responding to the COVID-19 pandemic. The Office of Financial Management has submitted an unanticipated receipt and allocated funds for the agencies and activities shown on the attached list. Items not approved for funding (and therefore not on the attached list) will receive consideration again at a later date.

Even for requests that were not granted at this time, if you have not applied for FEMA reimbursement yet, please apply for **expedited** reimbursement as soon as possible. See the Military Department's [FEMA Public Assistance resources](#) and [application](#). At this time, FEMA Public Assistance will reimburse for 75 percent of eligible expenses. If statewide FEMA-eligible costs exceed \$1 billion, the reimbursement will increase to 90 percent.
