- Lambarka aqoonsiga canshuur bixiyaha cusub.

Ogoow: Haddii aad gacanta ku qorayso halkii aad kumbiyuutar ku qori lahayd, fadlan si cad ugu qor FAR-WAWAYN oo khad buluug ama madoow oo kaliya ah. Foomamka lama aqbali doono haddii qad cad lagu tirtiray, haddii istilaab la saaray, ama haddii wax lagu dul qoray. Haddii aad tahay shirkad shisheeye, fadlan soo gudbi foomka W-8 ee IRS (Internal Revenue Service, Hay'adda Adeegga Dhakhliga Gudaha). Waxaad foomkaan ka heli kartaa Webseedka IRS. Waa inaad haysato US TIN (Taxpayer Identification Number, Lambarka Aqoonsiga Cashuur Bixiyaha) Mareykanka si aad iskaga diiwaan geliso Gobolka Washington.

Qaybta A - Xogta Xiriirka:

- Ciwaanka Boostada – Fadlan qor ciwaanka aad rabto inaad ku hesho lacagta iyo/ama fariimaha.
- Magaca Xiriirka - Qofka halkaan lagu magacaabay ayaa lala xiriiri doonaa si loo ansixyo isbadel kasta oo mustaqbalka ku yimaada diiwaangelintaada oo ay ku jirto lacag wareejinta elektarooniga ah. Haddii aad tahay ganaci, waxaa QASAB ah in la bixiyo magaca qofka lala xiriiraayo.
- Lambarka Talefoonka - Lambarka taleefanka qofka la xiriiraayo ee oggolaanshaha haysta.
- Ciwaanka limaylka - Ciwaanka iimaylka ee la bixiyay waxa loo isticmaali doona habka xiriirka aasaasiga ah (waxa laguugula soo xiriiri doonaa iimayl oo laguugo soo diri doonaa Lambarkaaga libiyaha Gobolka Washington).

Qaybta B - Diiwaangelinta (W-9):

- Waxaa QASAB ah inaad bixiso SSN (Social Security Number, Lambarkaaga Amniga Bulshada) ama EIN (Employee Identification Number, Lambarka Aqoonsiga Shaaqalaha). HA bixin labadaba.

Bangi Adeegsiga Lacag Wareejinta Elektarooniga ah:

Isbadelada iyo Ku darista Goobaha Dheeraadka ah:

Si aad isbadel ugu sameyso diiwaangelinta hadda jirta ama aad ugu darto/uga tirtirto goobo diiwaangelinta hadda jirta, fadlan buuxi oo soo dir Change Form (Foomka Badelka).

Sanduuqa Saxiixa:

Fadlan ku saxiix qalin qori ("saxiix qalinka lagu sameeyo"). Saxiixyada elektarooniga ah, la soo geliyo ama shaabada ah lama aqbali doono. Foomkaan looma aqoonsanaayo inuu ansax yahay ilaa in la saxiixo ma ahee.
