#### Project Summary

The Project consists of the renovation of the 24,000 SF Northrop Building on the campus of the Center for Deaf and Hard of Hearing Youth. The renovated building will create a building specific space for two Pre-K early learning classrooms, an early intervention space for infants, toddlers and their families, a museum of history of the Washington School for the Deaf, and administrative support space for educators. Site improvements around the Northrop building include additional infant and toddler play areas and the renovation of play equipment at the existing playground.

#### **Project Description**

#### 1. Identify the problem or opportunity addressed.

• This Capital Project Request is to complete the scope identified and funded in the 23-25 biennium. The previous funding allowed for programming, due-diligence, updated estimating and design to develop building permit and bidding documents for the modernization of the Northrop Building for the Pre-K early learning program. Additional funding is now needed to see the project through to completion with construction.

• The Washington School for the Deaf (WSD) has provided educational and residential services to students with deafness and hearing loss since 1886. In 2009, with the passage of RCW 72.40.015, the WSD was charged by the legislature to promote the development of communication-rich learning environments for deaf and hard of hearing students under the direction of a new state agency with expanded authority: The Washington Center for Deaf and Hard of Hearing Youth. The WSD is a fully accredited residential school serving students in Pre-K through 12th grade and is the state's only ASL-English bilingual residential school for deaf and hard of hearing students.

• To fully support deaf children's linguistic, cognitive, social and emotional development, WSD provides a comprehensive educational program that includes a commitment to promoting the acquisition, maintenance and study of American Sign Language (ASL) and English for all deaf and hard of hearing children.

• The Northrop Modernization will provide a state of the art facility, accessible early education and family intervention space for deaf and hard of hearing community. The renovated building will be a facility specifically designed to meet educational needs for Pre-K deaf and hard of hearing students, as well as a family intervention space for families of deaf infant and toddlers.

· Additionally, as part of the Memorandum of Understanding with DAHP for the Academic Building, the second floor of the Northrop building includes a Museum. This museum will exhibit the artifacts accrued during the 120-year history of the Washington School for the Deaf.

#### 2. What will the request produce or construct?

• Renovation and modernization of the historic Northrop Building for the Pre-K early learning center at the Washington School for the Deaf (WSD) campus. Construction starting in Summer 2025 and completion targeted for Fall 2026.

3. How would the request address the problem or opportunity identified in question 1? What would be the result of not acting? • The Northrop Modernization would provide an early education facility for deaf and hard of hearing children. The building will be updated to meet accessibility requirements, as well as updated to meet regulatory requirements to address life-safety concerns.

• Museum space will be redesigned at the second floor to provide an expanded and state of the art facility to exhibit artefacts from the 120-year history of the Washington School for the Deaf.

• The result of not acting would keep children in inadequate classroom spaces that are not designed to facilitate early childhood learning. The building would not meet the accessibility needs of occupants, nor align with deaf space design principals to provide a facility for deaf occupants. Additionally, the Northrop building would continue to have high operating

o Option 1 was not an option. Due to the age of the building, the existing classrooms have hazardous materials which need to be remediated. The building also does not meet the current Washington State Energy code due to inefficiency of the building envelope and mechanical and electrical systems. This increases the general operating expenses of the building.

o Option 2 included upgrading the building envelope and renovating the building with new interior finishes and building layout to meet program requirements. Replacing the existing single glazed window system with new triple pane, thermally broken window system. Also adding insulation at exterior walls to meet the WSEC and reduce overall operating costs. Updates to all mechanical and electrical systems.

o Option 3 modernizes the building in Option 2, and provides a ground source open loop water cooled variable refrigerant flow mechanical system.

o During the design process, it was determined that option 3 was not viable due to the cost of tying into the existing ground source open loop system.

5. Which clientele would be impacted by the budget request? Where and how many units would be added, people or communities served, etc.

• The Washington School for the Deaf (WSD) has provided educational and residential services to students with deafness and hearing loss since 1886. In 2009, with the passage of RCW 72.40.015, the WSD was charged by the legislature to promote the development of communication-rich learning environments for deaf and hard of hearing students. The WSD is a fully accredited residential school serving students in Pre-K through 12th grade and is Washington State's only ASL-English bilingual school for deaf and hard of hearing students.

• The Washington School for the Deaf has seen a 15% increase in enrollment year over year. The Northrop building would serve the youngest learners by providing a facility for children from birth through pre-kindergarten. Additionally, the building will house a outreach program for parents of deaf children.

• As usable building capacity across campus will improve, the project will support over 60 children with daycare and Pre-K classes, along with support services such as OT/PT, Audiology, a new Kitchen and a Family Room to support parent training. The building will also support history of the campus and alumni with an upgraded Museum that will contain historical artifacts.

learning programs at the Northrop Building is the next immediate priority.

• The master planning process begun in the early 2000's resulted in a clear vision for the future of CDHY's program development and the WSD campus. CDHY's Outreach Program is seen as a vital part of involving the larger deaf community throughout the State. Programs that bring the outside community to the school and take the students out into the surrounding community will form bridges that give the students a sense of themselves, life-skills, and the confidence to participate fully in society. The existing Pre-K facilities are outdated, unsafe and preclude the kinds of instruction envisioned in the Learning Plan®.

The current request will abate hazardous materials, provide improved Pre-K early learning facilities, and help work towards completion of the campus masterplan.

• This project is targeting LEED Silver Certification and the following strategies are being explored in design will support sustainable construction, operations, and reduces greenhouse gas emissions: the existing site retains 100% of rainfall so no detention is required; proposed plantings will be native species that do not require irrigation; the new building's envelope will be commissioned to ensure exterior envelopes meet Enhanced Commissioning requirements; new mechanical and electrical systems will Optimize Energy Performance of the building; interior finishes will meet Environmental Product Disclosures ensuring safe Low Emitting products are specified; the renovated windows will be specified such that the classrooms will achieve maximum daylighting but, with less glare.

• There is a reduction of carbon pollution through re-use of existing building and leveraging embodied carbon. When considering total carbon footprint - operational carbon (from building energy use) plus embodied carbon (from building construction), over the next 25 years the embodied carbon from construction can exceed the operational carbon for a new building. By reusing the existing building, the project is making a huge reduction in embodied carbon compared to building new. In addition, since the Northrop building is an historic building, additional LEED points are achieved.

• The Washington School for the Deaf (WSD) serves as cultural hub to the deaf and hard of hearing community, one of Washington's most underserved populations. "Bilingual Empowered-Successful for Today and Tomorrow-the BEST!" The Washington School for the Deaf is the state of Washington's only ASL-English residential bilingual school for deaf and hard of hearing students.

· Washington School for the Deaf is a fully accredited school serving students in Pre-K through 12th grade. WSD offers:

o Free transportation and housing for residential students outside the greater Vancouver area.

o A twenty-four hour learning environment 5 days a week.

o Positive role models: Approximately 80% of instructional and cottage staff is deaf.

o Strong linguistic support for acquisition of American Sign Language and English Rich academic & cultural atmosphere Environment that encourages students to communicate freely, grow socially and emotionally, and achieve high standards.

o Student organizations & extra-curricular activities including competitive varsity sports, cheerleading and intramural sports,

Is there additional information you would like decision makers to know when evaluating this request? • The Washington School for the Deaf has seen a 15% Increased enrollment year over year which indicates there is a greater need to serve students. Additionally, deafness is often associated with other physical impairments. The current Northrop building does not provide equitable wheelchair access to the entire facility for a child or parent who relies on the use of a wheelchair.

• The current facility is not supportive of PreK program requirements – this project creates a program-specific facility with new interior spaces updated to incorporate best deaf space design practices. For example, updated lighting and interior finishes to make signing easier to read. The building will also collocate several program elements that are currently spread throughout campus.

• The redesigned Museum space to exhibit artefacts from the 120 year history of the Washington School for the Deaf is a requirement from DAHP as part of the campus wide updates.

Reappropriation: if the project was originally funded prior to the 2025-27 biennium, describe the project and each subproject, including the original appropriation year, status of the project and an explanation why a reappropriation is needed. • The legislative intent with the 2023-25 biennium funding for this project was to fund the design, estimating, and due-diligence required to convert the existing Northrop building into the Pre-K center for the campus. This 2025-27 request is to fund the full remaining scope and services required to construct the project. The design has been completed to 95% Construction Documents and has been submitted for building permit review. The reappropriation is needed to fully fund the project for construction based on the updated estimate.
