## ORDINANCE NO. 1572 N.S.

## AN ORDINANCE ANNEXING CITY PROPERTY INTO THE CITY OF COLVILLE AND ZONING SAID PROPERTY AS OPEN SPACE

WHEREAS, the City of Colville owns property purchased for city water wells and wellhead protection (includes Tax Parcels 8002658, 2242430, 2242435, 2242439) and the City Council desires to annex said property for municipal purposes into the City of Colville; and

WHEREAS, on August 30, 2016, the City Council held a public hearing to consider annexation of the property and determined that is shall be zoned Open Space (OS) consistent with the Comprehensive Plan Preferred Land Use Designation for Public Use.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF COLVILLE does hereby ordain as follows:

<u>SECTION 1</u>. That the real property legally described as follows:
