ORDINANCE NO. 1460 AN ORDINANCE AMENDING ORDINANCE NO. #1439 ANNEXING CERTAIN LANDS TO THE CITY OF OTHELLO

WHEREAS, on July 27, 2015, the City of Othello annexed certain land into the City limits pursuant to RCW, Chapter 35A.14 and RCW, Title 35A by Ordinance No. 1439;

WHEREAS, the legal description of the land annexed by Ordinance No. 1439 included a portion of right-of-way previously dedicated for State Route 26;

WHEREAS, the City of Othello did not intend to annex any portion of State Route 26;

WHEREAS, the City wishes to amend Ordinance No. 1439 so that the annexation does not include any portion of State Route 26;

THE CITY COUNCIL OF THE CITY OF OTHELLO, WASHINGTON ORDAINS AS FOLLOWS:

Section 1. Amendment of Ordinance No. 1439. The City of Othello hereby amends the description for the real estate situated in Adams County, Washington that was annexed into the corporate limits of the City of Othello by Ordinance No. 1439, as follows:

That portion of the southwest quarter of the southwest quarter of section 2, Township 15 North, Range 29 East, W.M., Adams County, Washington, described as follows:

Section 3. Effective Date. This annexation shall be effective five days after passage of this ordinance and publication of its summary.
