

Specification for Class of

TRUCK DRIVER 2

Abolished Initially Effective January 13, 2006

Abolished Final Effective February 10, 2006

Definition: Operates, a majority of the time, medium to large trucks, buses, and specified special vehicles.

Distinguishing Characteristics: Operates, a majority of the time, commercial class vehicles rated over 28,000 GVW, buses with a rated capacity of 9 through 30 passengers, or other equipment in the Equipment List adopted by the Personnel Board for this class. Incumbents may supervise other employees.

Typical Work

Drives truck or dump truck to haul personnel, material, supplies and/or equipment;

Drives medium to large buses to transport residents or personnel;

Greases, oils and makes minor repairs to equipment;

Loads and unloads trucks;

May direct work of assigned assistant;

Performs other work as required.

Knowledge and Abilities

Knowledge of: rules of safe operation of equipment; State motor vehicle laws; rules governing operation of State equipment; methods, tools and materials used in servicing and maintaining equipment.

Ability to: operate heavy trucks and buses in safe and skillful manner; make adjustments and emergency repairs to equipment; follow oral and written instructions; keep simple records.

Minimum Qualifications

One year of experience in operation of commercial class trucks of 18,000 GVW or more, or one year as a Truck Driver 1 and a record free from serious traffic violations is required.

Note: Some positions in this class may be required to have a Class A, B or C Commercial Drivers License (CDL) with appropriate endorsements as required by Federal law (Commercial Motor Vehicle Safety Act of 1986).

EQUIPMENT LIST FOR TRUCK DRIVERS

Truck Driver 1

All commercial type vehicles over 3/4 ton and up to 28,000 GVW (includes special use vehicles such as dump trucks, compactor trucks, etc., up to 28,000 GVW).

Forklifts.

Truck Driver 2

All passenger carrying vehicles with a rated capacity between nine (9) through thirty (30) passengers.

All commercial vehicles rated over 28,000 GVW (includes special use vehicles such as dump trucks, compactor trucks, water trucks, etc., over 28,000 GVW).

Truck-Trailer combinations over 28,000 GVW and under 60,000 GCW.

Special Vehicles

All pulled trailers specially designed to carry handicapped persons in wheelchairs (rated capacity 12 passengers or more).

Truck Driver 3

All passenger carrying vehicles with a rated capacity of thirty-one (31) passengers or more.

Semi-truck and trailer vehicles (5th wheel) rated at 60,000 GCW or more.

Truck-trailer combinations (60,000 GCW or more).

Note: All above references to GVW or GCW relate to allowable highway "gross vehicle weight" or "gross combined weight."
